# I. Language

In general, contributions to the journal are to be written in **British English**. This does not apply when quoting legislation, judgments, etc. which are, for example, written in American English.

**Single quotation marks** ('...') are to be used. Double quotation marks ("...") are used for quotations within quotations. German ("...") or French style (« ... ») quotation marks may be used when used in the title of a publication cited in the bibliography or if used within a quotation.

**Gender-specific pronouns** ('he', 'she', 'his', 'her', etc.) may be used occasionally and, where possible, not repeated more than once in the same sentence. Do **not alternate** between masculine and feminine forms. To use of gender-specific pronouns can be avoided by rephrasing by using the plural form, using the passive or omitting the pronoun entirely, when appropriate. **Job titles** such as 'lawyer', 'judge', 'professor' and 'manager' refer to either sex. A gender-neutral alternative is to be used where available (e.g. policeman  $\rightarrow$  police officer, chairman  $\rightarrow$  chair). **Dates** are expressed in the format **DD.MM.YYYY**. Use the word and figure where only the month (word) and year (figure) are stated.

**Numbers** up to and including ten are expressed in words and in figures from 11. However, figures are used for **ranges** with the numbers linked by an en dash (–)

Units of measurement are expressed in figures.

Figures and words are **used** for **round numbers** (above a million)

2.3 million inhabitants

Except for page numbers, commas are used in numbers of four digits or more

The international **abbreviation** is used for **currencies** (EUR, USD, GBP, etc.), not symbols ( $\in$ , \$,  $\pm$ , etc.).

## II. Structure

Each contribution shall be structured using the following consistent and logical sequence for headings and subheadings:

Use initial capitals in headings.

## III. References

**References** in printed works are made in footnotes; in-text citations or endnotes are not to be used. References to legislative provisions may be inserted in round brackets in the main body of the text.

Arabic numbers (1, 2, 3, etc.) are used for footnotes.

**Footnote markers** should in principle only be placed after the punctuation within or at the end of a sentence. Where several references are used within a sentence, the footnote marker may be placed at the end of the relevant word or phrase.

An **asterisk** footnote (\*) is used at the beginning for an acknowledgement.

Do not use **small capitals** (EXAMPLE). The 'small caps' function can be (de-)activated in MS Word under Font  $\rightarrow$  Effects  $\rightarrow$  Small caps.

Each footnote begins with a **capital letter** (except cf., e.g., i.e., and ibid.) and ends with a **full stop**.

## 1. Legislation

**EU legislation** may be cited using the official or commonly used short title or abbreviation (e.g. Rome I, Digital Content Directive, GDPR, DMA). The full title and OJ reference are to be cited in a footnote the first time a reference to the legislation is made. No cross-references to the footnote are necessary when further references are made.

**National legislation** may be cited using the official abbreviation or the abbreviation generally accepted in the jurisdiction. This also applies to the use of '§', 'Art., 'Sec.', etc. If an abbreviation is used, provide a definition in the main body of the text and, if necessary, the original name of the legislation.

References to **subdivisions** within a legislative provision are indicated in brackets. Where necessary, references to a specific part of a provision (e.g. sentence, alternative or number in a list) are to be indicated using sent. / alt. / no.

#### 2. Case Law

#### a) CJEU

CJEU (Court of Justice and the General Court) are cited with CJEU, case number, case name (in italics) and ECLI number. References to specific paragraphs are indicated with para(s).

**Advocate General** (AG) opinions are cited giving the name of the Advocate General. Note that AG opinions have a different ECLI number to the decision of the court.

#### b) European Court of Human Rights

Cases from the European Court of Human Rights are cited using the following format: ECtHR App. No., *parties*, para(s).

#### c) National Courts

Cases from national courts are cited in accordance with the **style typical in the jurisdiction**.

## 3. Literature

When citing titles written by **up to three** authors, the names are separated by an oblique (/). For publications from **four or more authors**, only the first author's surname is given followed by 'et al.'.

Where **more than one reference** is included in a footnote, the entries are to be listed **chronologically** and separated by a semi-colon.

#### a) Books

Author(s), *title* (edition [abbreviation: edn], publisher year of publication) page /margin number (mn.).

#### b) Contributions to Edited Books

Author(s), 'title of contribution' in editor(s) (ed./eds), title of book, edition (where relevant), place of publication year of publication, first page of the contribution.

#### c) Commentaries

Author(s) in editor(s) (ed/eds), *title of commentary* (volume of multi-volume work in Roman numeral if applicable) (edition (where relevant), publisher year of publication) provision margin number

#### d) Journals

Author(s),' title of article' (year) volume number abbreviated title of journal first page of article, pinpoint (where applicable).

#### e) Online Journals / Working Papers

Author(s),' title of article' (year / date written) volume number abbreviated title of journal <DOI> (accessed DD.MM.YYYY)

## f) Official Documents

The **Official Journal of the European Union** is cited as [Year] OJ series (L/C) number/page.

**EU documents** (e.g. proposals, resolutions, etc.) are to be cited by:

Name of body, 'title of the document', document reference number or Official Journal reference (where available. If no such document is available, include the date of the document), page / margin number (mn.)

European Commission, 'Towards a comprehensive European international investment policy', COM(2010) 343 final, 4.

European Parliament, 'European Parliament resolution of 6 April 2011 on the future European international investment policy (2010/2203(INI)' [2021] OJ CE 296/34.

Council of the EU, 'Conclusions on a comprehensive European international investment policy', 25.10.2010.

References to documents from **national** bodies (e.g. Parliament) are made in accordance with the style in common use in the jurisdiction.

## g) Websites / Blogs

Authors, 'Title', date, <URL> (accessed DD.MM.YYYY)
